WHEREAS in the application the Applicant requested authority to exercise full trust powers under the Act;

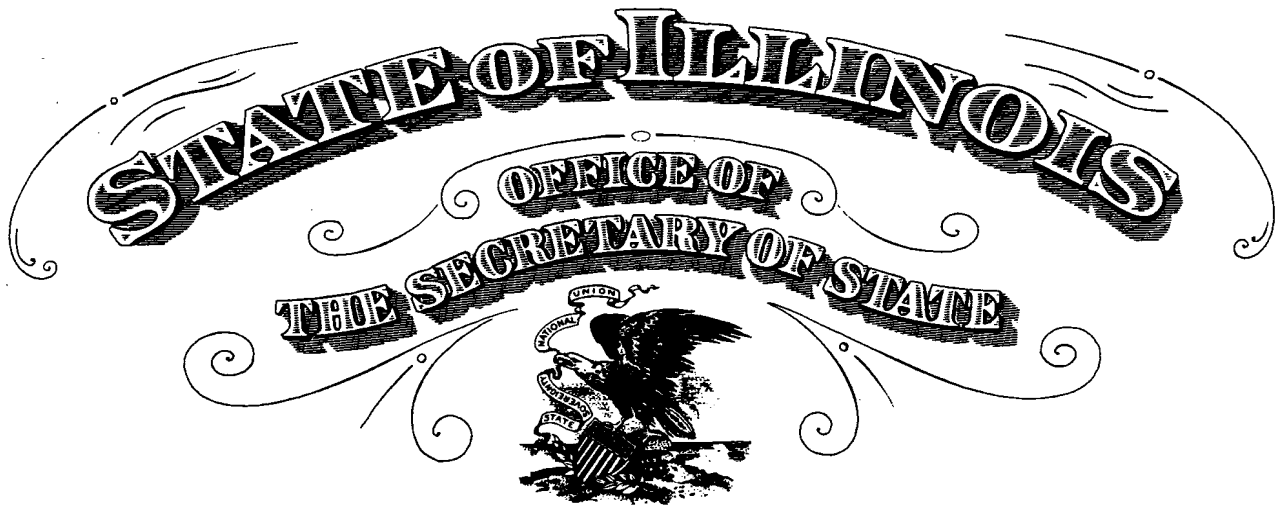
