- 1. Final Judgment. Plaintiff is entitled to entry of final judgment.
- **2.** Value of Claim. At the initiation of this action, in accordance with section 28.241(1)(a)2.b., Florida Statutes, plaintiff estimated the amount in controversy of the claim to be \$241,384.69. - **4. Interest.** The total amount in Paragraph 3 shall bear interest from this date forward at the prevailing statutory rate of interest.
- **5.** Lien on Property. - **9. Right of Redemption.** On filing the certificate of sale, defendant(s) and all persons claiming under or against defendant(s) since the filing of the notice of lis pendens shall be foreclosed of all estate or claim in the property, except as to claims or rights under chapter 718 or chapter 720, Florida Statutes, if any.
- **10.** Right of Possession. Upon filing of the certificate of title, the person named on the certificate of title shall be let into possession of the property. If any defendant or tenant remains in possession of the property, an Order Granting the Motion for Writ of Possession shall be entered without further notice or hearing, subject to the purchaser's compliance with Section 83.561, Florida Statutes.
- 11. Jurisdiction Retained.
